Call for Abstracts

ICOEH 2016 invites submission of abstracts describing the status, gaps and needs in Occupational and Environmental Health in all the theme areas of the conference. The papers can be submitted for oral and/or poster presentations. All abstracts will be evaluated on the basis of scientific merit by peer review. Preference will be given to those submissions that address a substantive issue by integrating across different areas of conference themes (i.e., mainstreaming at policy and planning level / at research and academic level / at implementation level /in MSME, MNCs & informal sector and at rehabilitation level etc.). The ICOEH Program Committee will make decisions regarding acceptance of submissions and notify corresponding authors by July 15, 2016.

Deadline for Receipt of Abstracts

Submissions must be received electronically and no later than 11:59 P.M. IST on Sunday, June 15, 2016, to be considered for inclusion in the program. Please review the submission instructions carefully.

All presenters will be expected to register and pay for the conference. Notification of acceptance or rejection of abstracts will be e-mailed to the corresponding authors by July 15, 2016.

Abstract Registration

To use the online submission system, you must first register. A registration link is placed on the home page. Here you will fill in your basic contact information and other details and your email id provided by you will be used as your unique registration login ID for the registered name. Required fields are marked with a red asterisk (*). Upon successful registration, the link for submission of abstract will appear on your screen.

For later abstract submissions, you will require this login id & password for online submission of your abstract on abstract submission page. **Please register only once.**

Main Submission Page

After successful registration, you will be provided with the link of abstract submission page. You can submit maximum of three (3) abstracts under the registered Id. Enter the abstract as detailed on the page in the customized form.

Presentation Formats

Paper Only

Abstracts that receive high peer-reviewed ratings and cluster around common themes will be selected for oral presentations for 10 minutes each. Please note that program time constraints limit the opportunity for lengthy oral presentations.

Poster Only

Poster sessions allow presenters to discuss their research with interested colleagues over a period of 90-120 minutes in an informal setting to maximize exchange of results and promote communication among researchers with common interests. Poster submissions judged rigorous and significant may be selected for presentation as a paper (if the author agrees).

Paper or Poster

Any abstract submitted under the "Paper or Poster" option that is not selected for an oral presentation automatically will be considered for the poster presentation.

Abstract Submission Instructions

ICOEH uses an electronic process for the submission of abstracts. Submitting authors need internet access and an e-mail address. Electronic submissions must be received by 11:59 P.M. IST on Sunday, June 15, 2016, to be considered for inclusion in the program.

When preparing an abstract for submission, please carefully follow the instructions below:

- All abstracts must be prepared in plain text, in English with no embedded symbols or formatting characters. Submissions should not include charts, graphs, tables or references. Please spell out the symbols (alpha, beta, microns, picomolar, etc.) or translate them (mean, chi square, etc.) in your abstract submission.
- Limit the abstract to 300 words in length (including spaces but NOT including title, authors or affiliation information). Include names of the authors and the corresponding author's name and address.
- If accepted, your author-prepared abstract will be published exactly as it appears on your electronic submission.
- Please provide a complete mailing address, including e-mail address, with your submission. The ICOEH Office will communicate with the corresponding author through the e-mail address that is given at the time of submission. Should this e-mail address change at any time, please notify the ICOEH Office immediately so that you receive timely correspondence regarding your abstract submission.
- Proofread your submission. If included in the program, your author-prepared abstract will be published exactly as it appears on your electronic submission. ICOEH will not be responsible for author's errors.
- Consider submitting your abstract earlier than the deadline. ICOEH welcomes early submissions!
- Each corresponding author will receive an e-mail confirmation from the ICOEH Office. Please keep a copy of this confirmation e-mail.
